### *Frequently Asked Questions*

#### **How may I obtain a copy of my training transcripts?**

A Georgia Peace Officer's complete training transcript is maintained by the Georgia Peace Officer Standards and Training Council (POST) and can be accessed by the officer online at [www.gapost.org](http://www.gapost.org). To obtain transcripts for training that was attended at the North Central Georgia Law Enforcement Academy only, contact our registrar at 770.499.5072.

#### **What classes are required for intermediate certification?**

Criminal Procedure, First Responder, Health and Wellness, Interpersonal Communications/Crisis Intervention, and Officer Survival

#### **What classes are required for advanced certification?**

Advanced Firearms, Advanced Report Writing, Advanced Traffic Law, Crime Scene Processing, Interviews/Interrogations, Search warrants/affidavits, and Specialized Patrol.

#### **If I leave law enforcement, how many hours do I need when I return?**

If you got 20 hours in the year you quit, you will only need 20 hours in the year you return to law enforcement. If you didn't get 20 hours in the year you quit, you will need 20 hours for that year plus each year you were out of law enforcement. For more information contact P.O.S.T. at (770) 732-5974

#### **If I am P.O.S.T. certified but not currently employed in law enforcement, may I sign up for classes?**

No, NCGLEA does not offer in-service or advanced training for individuals not currently employed in law enforcement.

## What should I wear to class?

### Here are a couple of scenarios...

Students that are attending Basic Mandate or Basic Jail should wear their training uniform unless specifically told otherwise by their agency.

Basic mandate students should bring all equipment associated with a uniformed patrol officer to include gun-belt, body armor, belt keepers, training gun (blue or orange plastic), and a flashlight to class with them on a daily basis.

Students attending classes beyond basic mandate should wear their training uniform unless specifically told that other attire is required for the class.

P.O.S.T. Certified Officers attending training classes may bring their assigned duty firearm into the classroom.

Classes that will require physical training will require students wear "work appropriate" attire to class such as athletic pants, sneakers, and a plain blue, white, or black T-shirt.

Students are expected to maintain a level of professionalism in the attire they wear to the academy.

## What are the costs associated with training classes?

NCGLEA charges \$12.50 per credit hour for students. An example: a 40-hour course would cost \$500 for a non-subscribing agency.



## What is a subscribing agency?

NCGLEA charges agencies that wish to subscribe to unlimited training classes per year a \$50 fee per sworn officer their department has. An example: an agency with 50 sworn officers would subscribe for \$2,500 per year.



## May I attend the Basic Law Enforcement Training Course by paying for it myself?

Yes. An individual who is not currently employed by a law enforcement agency may attend the course at their own expense through the Pre-Service program. The Pre-Service program places the academy in the place of an employer as the potential student sponsor. All associated costs (tuition, background investigation, polygraph, etc.) are absorbed by the potential student.

## Are showers available on site?

The academy does not currently have showers available to students.
